

## **BRIEF IN RESPECT OF BENEVOLENT FUND BRANCH**

A District Benevolent Fund Board has been established at every District and Deputy Commissioner is the Chairman of the Board. The District Benevolent Fund Board deals with the cases of Non-Gazetted Government, Servant.

### **BENEFITS OF BENEVOLENT FUND.**

Following benefits which a government servant or his family can get out of Benevolent Fund:-

#### **(i). MONTHLY AID GRANT:-**

Monthly aid is granted to the widow of government servant, if the government servant died during service for life time and for fifteen years if died after retirement, or invalid retired in Category "A". Monthly Aid grant is granted t the following rates:-

#### **BASIC SCALE**

#### **RATE**

BS 01 to 10

Rs. 1950/- per month **(November 2017)**

BS 11 to 15

Rs. 2500/- per month **(November 2017)**

BS 16 to 17

Rs. 3500/- per month

BS 18to 19

Rs. 6000/- per month

BS 20 and above

Rs. 8000/- per month

#### **ELIGIBILITY:-**

- a. If a government servant died during service his widow shall get monthly grant for life provided she does not remarry.
- b. If the female government servant died during service his husband/ family member for 15 years.
- c. If a government servant dies within 15 years of the date of retirement, the grant shall be given to his / her family as the case may be in the following order of precedence subject to the conditions as indicated against each:-
  - i. For the unexpired period of 15 years from the date of retirement subject to the condition that widow/ widower does not remarry and the widower does not have another wife at the time of death of his spouse. If there are more than one widow grant shall be divided amongst them in equal shares.
  - ii. For the unexpired period of 15 years from the date of retirement or till the youngest child attains the age of 21 years. In the case of a female child till her marriage.
- d. If a government servant is invalidated during service, he /she shall be entitled to a monthly grant for 15 years from the date of retirement due to invalidation, provided that he/she has been declared invlied by the concerned Medical Board in Category-A on account of loss of limbs or

complete loss of eye sight or complete loss of speech or complete deafness or a paralysis or complete lunacy or advanced terminal disease and the concerned. B.F. Board after due inquiry is satisfied that he/she is totally incapacitated for any gainful employment in future.

- e. In case of death of the Invalidated grantee within 15 years of his retirement the grant shall be admissible to his/ her family members as the case may be, in the following order of precedence subject to the condition as indicated against each:-
- i. For the unexpired period of 15 years from the date of retirement subject to the condition that widow/widower does not remarry and the widower does not have another wife at the time of death of his spouse. If there are more than one widow grant shall be divided amongst them in equal shares.
  - ii. For the unexpired period of 15 years from the date of retirement or till the youngest child attains the age of 21 years whichever is earlier.
  - iii. For the unexpired period of 15 years from the date of retirement or till the youngest attains the age of 21 years. In the case of a sister till her marriage or attainment of the age of 21 years whichever is earlier.

**(ii). MARRIAGE GRANT:-**

Marriage grant out of benevolent fund is granted on the marriage of daughter of government servant as under:-

#### **ELIGIBILITY:-**

- f. If a government servant died during service his widow shall get monthly grant for life provided she does not remarry.
- g. If the female government servant died during service his husband/ family member for 15 years.
- h. If a government servant dies within 15 years of the date of retirement, the grant shall be given to his / her family as the case may be in the following order of precedence subject to the conditions as indicated against each:-
  - iii. For the unexpired period of 15 years from the date of retirement subject to the condition that widow/ widower does not remarry and the widower does not have another wife at the time of death of his spouse. If there are more than one widow grant shall be divided amongst them in equal shares.
  - iv. For the unexpired period of 15 years from the date of retirement or till the youngest child attains the age of 21 years. In the case of a female child till her marriage.

**IV) Educational scholarship per Annum:**

Educational scholarship grant while in service / retirement / widows of government servant is permissible to only two children at a time.

**ELIGIBILITY**

- d. Government servant who is in service.
- e. Widows of government servants.
- f. Children of government servant must have 50% marks.

#### **ELIGIBILITY:-**

- k. If a government servant died during service his widow shall get monthly grant for life provided she does not remarry.
- l. If the female government servant died during service his husband/ family member for 15 years.
